### **Privacy Policy**

Thank you for visiting our website. We are committed to protecting and respecting your privacy.

This Privacy Policy sets out the basis on which we process any personal information we collect about you or that you provide to us.

We may change this Privacy Policy from time to time, so please check back frequently.

## About us

This website is operated by iCCOMMODATE Ltd. For the purposes of UK data protection law, the data controller is iCCOMMODATE Ltd of 447 Smithdown Road L15 3JL.

### Information we collect about you

We collect and process the following information about you:

- Information you provide to us. You can provide us with information about you by filling in forms on our website or by contacting us by telephone, email or otherwise. # Sharing your personal information
